

STATEMENT OF FINANCIAL SUPPORT

The United States Citizenship and Immigration Services (USCIS) require international students to submit proof of financial solvency. **The estimated amount required for tuition and living expenses is \$25,000 U.S. dollars per year. Additional proof of \$ 5,000 is required for each dependent.**

This amount should meet the educational expenses (tuition fees, room and board, and other miscellaneous expenses) during the first year at Austin Community College.

- This form must bear the **original signature of the sponsor** (if the student is self sponsoring, the student's signature is required on this form).
- This form must bear the **original signature of a bank official and an official seal or stamp from the bank.**
- By signing the form, the bank official is verifying that the sponsor has a minimum of \$25,000 U.S. dollars (or the currency equivalent) in their bank, on deposit, in a checking or savings account.

Please note the following information below:

- The sponsor has the option of providing an official bank letter or bank statement *instead of* having the last portion of this form (the bank portion) completed. The official bank letter or bank statement **must clearly reflect the date, Sponsor's name, amount, and type of currency**; on deposit, in a checking or savings account. It does not have to be reflected in U.S dollars.
- If the sponsor submits a statement showing CDs/Mutual Funds, Pension Funds, 401K, Stocks or Trust Funds and these funds are not immediately available, the sponsor must submit a copy of the terms, translated in English (if applicable), explaining what arrangements must be made to liquidate the funds into cash, and the cash value upon liquidation.

The date on the form, the bank letter, or the bank statement must be dated **no more than six months** prior to the start of the semester for which the student is applying.

On-campus employment is not and will not be considered in determining financial solvency.

Faxed, photocopies, or scanned/imaged copies are NOT accepted.
All original financial documents will be copied, certified, and returned upon request.
